HOA Dues

Thank you to the 95% of our residents who have already paid their 2003-04 dues. At the November 4 Annual Meeting, there will be discussion on increasing the annual dues to an amount between \$60 and \$100. A 2004 -2005 budget will be presented and the floor will be open for discussion. There will also be consideration given to charging late fees.

An invoice is enclosed for \$45 (if you are current through September 2004). This \$45 will be applied as a first payment on your 2004-2005 dues. The balance due will depend on the decision at the annual meeting.

Many thanks to all who donate their time, energy, and money to offer an enjoyable place for everyone from babies to seniors to swim, exercise, and visit with neighbors during the summer months. Bylaw Changes

At the November 4 Annual Meeting, we will present proposed new bylaws. After much research, input from legal sources, and discussion the Wedgewood Homeowners Association Board has approved a restated and revised set of ByLaws to replace the long-outdated set adopted approximately 25 years ago. The full text will be available online at the website, www.wedgewood-ba.com, and at the annual meeting. Aside from wording changes, these represent the areas of effectual change.

Old

(III, IV) Type A, B, C Memberships (A- HOA only; B- HOA+Pool; C- Pool only)

New

Mandatory membership via covenant change in 1999 made those classes of no practical effect. There is now only one membership. Pool use is still open to all who pay the appropriate pool membership.

Old

(III,2) References to when the first terms started back in ~1976 removed.

New

(IV,4.2) Wording changed to reflect ongoing stagger of terms. Added 2 term limit for offices, unless voted by the Board or nominated and elected at the annual meeting.

New

(XI, 11.1) General recognition of HOA power to enforce any architectural related stipulations contained in the covenants.

New

- (XII)
- (12.1) Legal ability to file liens recognized (defined by state statute.) Special assessments recognized. Ability to charge up to 12% late fee if dues not paid within 90 days.
- (12.3) Method defined for changes in dues. 30 days before Fiscal Year start for Board initiation.
- (12.4) Limitations to dues increases. No more than 100% increase over any 5-year period unless changed at an annual or special meeting.
- (12.6) Special assessments defined.
- (12.8) Method of crediting payments spelled out.

New

- (XIV) Other Member Obligations
- (13.1) Liens recognized. Fines levied on homeowners added.
- (13.2) Appeal procedure for fines.

GreenBelt Committee Meets

Initial conversations have been held with the city of Broken Arrow regarding the Greenbelt (*starts at the park, goes south, crosses Poplar & continues west to Aspen*). It is city property, not Wedgewood HOA. The first committee meeting was held on September 3. The decision at the meeting was to initially survey all residents who border the greenbelt and solicit their opinion on what improvements could/should be done. That survey will be conducted in the next few weeks.

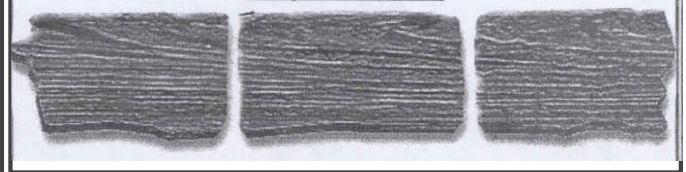
